He heads the Global Progress Commission for the renewal of the S. I. since September 1996.

In May 1993, Mr. González was awarded with the Charlemagne Prize.

On March 3, 1996 he was again elected Member of the House of Deputies for Madrid.

In December 1996 he was appointed as Special Representative of the Chairman-in-office of the OSCE to head a mission into the Federal Republic of Yugoslavia.

In October 1997 He was awarded with the Great Golden Cross for Merit by the Republic of Austria.

He chairs the Global Progress Foundation.

He is currently carrying out a Mission to mediate in the conflict of the Federal Republic of Yugoslavia, including Kosovo, appointed by de Chairman-in-Office of the OSCE, and as a Special Representative of the EU for the resolution of the problems of the FRY, including Kosovo, with the support of the UN Security Council.

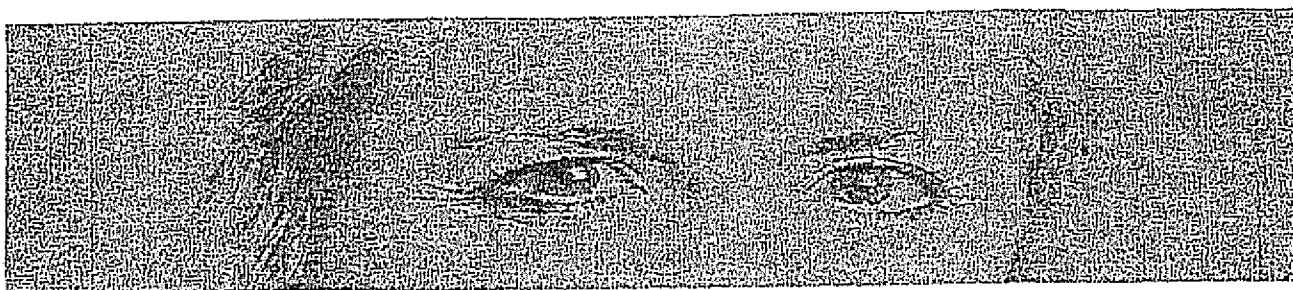
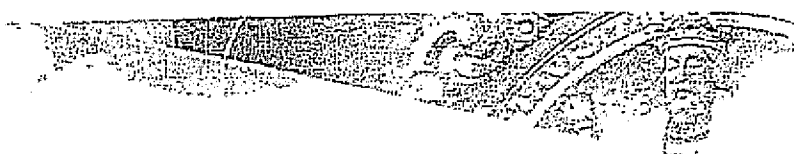

Rem Koolhaas founded the Office for Metropolitan Architecture in 1975 together with Elia and Zoe Zenghelis and Madeleine Vriesendorp as a collaborative practise. Having worked as a journalist and script writer before becoming an architect, Koolhaas graduated from the Architectural Association in London, and in 1978 published *Delirious New York*, a Retroactive Manifesto for Manhattan. In 1995, his book *S,M,L,XL* summarized the work of OMA and established connections between contemporary society and architecture. At this moment Rem Koolhaas is heading the work of OMA as well as AMO – the conceptual branch of OMA, a think tank focused on social, economic, and technological issues.

Rem Koolhaas is a professor at Harvard University where he conducts the Project on the City, a research program investigating changing urban conditions around the world. The projects include a study on China's Pearl River Delta (published as *Great Leap Forward*), an analysis of the role of retail and consumption in the contemporary society (*The Harvard Guide to Shopping*), and studies on Rome, Lagos, Communism, preservation and Beijing.

Recently, OMA has completed the Netherlands Embassy in Berlin, a campus center at the Illinois Institute of Technology in Chicago, the Prada Epicenter in Los Angeles and the Public Library in Seattle. The Seattle Library was chosen by TIME Magazine as The Best Architecture for 2004 and was described by the New York Times as: 'At a dark hour: Seattle's new Central Library is a blazing chandelier to swing your dreams upon. If an American city can erect civic project as brave as this one, the sun hasn't set on the West.' (May 16th 2004)

In April 2005 the Casa da Musica concert hall in Porto was completed and was already voted as one of the most important concert halls in the world by the New York Times (April 10th 2005).

In Asia, OMA is currently constructing the offices largest project to date, the 575,000m2 China Central Television Headquarters CCTV and Television Cultural Center TVCC in Beijing. In December 2007 the two towers of the CCTV building joined, marking an exciting moment in the project. CCTV is to be completed by 2009 and TVCC will be completed in time for the Olympics in 2008.

The work of Rem Koolhaas and OMA has been celebrated by several international awards, including the Pritzker Architecture Prize (2000) and the RIBA Gold Medal (2004). In 2005 Rem Koolhaas received the Mies van der Rohe Award for the Netherlands Embassy, Berlin. In making their decision to award the Netherlands Embassy, the jury commended the 'quality of the urban reflection and intelligence of the concept implemented, especially as regards the unprecedented concept of 'trajectory' and the new potential it brings to this project of great complexity'. In 2001 Rem Koolhaas was awarded the French Legion of Honour and 2007 the University of Leuven, Belgium, honoured him with a doctorate *honoris causa*. In the same year Rem Koolhaas was elected to the European Council of Foreign Relations.

In addition to the architectural work of OMA Rem Koolhaas also addresses theory, culture and politics with the creative think tank AMO. Recent AMO projects include a study for the European Commission on the visual identity of the EU, image restructuring for Condé Nast magazines *Lucky* and *Wired*, a study on the future of the automobile for Volkswagen and a study concerning preservation for the city of Beijing.

By combining AMO and OMA Rem Koolhaas is seen as one of the most important thinkers of the last decades. Nicolai Ouroussoff critic for Los Angeles Times underlines this by: 'There is little question that Rem Koolhaas is one of the most influential architects of the last 20 years. As an architectural thinker, his cool analytic approach to design, sprinkled with a healthy scepticism, has informed the profession that his fingerprints can be found on the work of almost any young architect today.' (May 21st 2004)

Koolhaas' work was the subject of various overview exhibitions, the most recent being *Content*, which opened at the Neue Nationalgalerie, Berlin in 2003 and at the Kunsthal (built by OMA) in 2004. In conjunction with the exhibition, a book of the same name was published in 2003 by Taschen Books. *Content* illustrates the ways in which Rem Koolhaas and OMA-AMO interact with the world and how the world in turn influences their work. An exhibition by AMO on representation in and the perception of Europe was on display last Fall in Brussels and at the Haus der Kunst in Munich. For the Biennale in Venice Rem Koolhaas curated in 2005 one of the exhibitions titled 'Expansion & Neglect' and in 2006 an exhibition titled 'The Gulf' exploring the vast urbanisation at the Gulf coast. More recently, Rem Koolhaas and AMO have produced *Al Manakh*, a study of the Gulf, which was published in autumn 2007 and coincides with OMA's continued architectural and theoretical presence in the Middle East.

Richard Lambert
Director-General of the
CBI

Having studied history at Balliol College, Oxford, Richard joined the *Financial Times*. He edited the Lex column in the 1970s, becoming financial editor in 1979. In 1982 he moved to New York as the Bureau Chief, returning to the UK a year later as Deputy Editor. He became Editor of the *Financial Times* in 1991 and during his 10 years in this role launched the US version of the newspaper.

From August 2002 Richard spent a semester at the Kennedy School of Government at Harvard University. He was subsequently asked to write the *Lambert Review of Business-University Collaboration*.

A member of the Bank of England's Monetary Policy Committee from Spring 2003 until Spring 2006, Richard took up the post of Director-General of the CBI in July 2006.

Since beginning his term he has focused his work on climate change, financial services, education and skills and science and technology.

In March 2008 it was announced he would become Chancellor of the University of Warwick from 1st August 2008.

Richard is a Board Member of Enterprise Insight and VisitBritain, and sits as a member of the Chancellor's High Level City Group, the National Council for Educational Excellence, the Apprenticeship Ambassadors Network, and the Employers Forum on Disability. He is a Commissioner of the UK Commission on Employment and Skills.

Richard is also a Trustee of the British Museum, a Trustee of the Centre for European Reform, and a member of the UK-India Roundtable.

He is married to Harriet and has two children. He enjoys the theatre and galleries.



Mario Monti has been a member of the European Commission in charge of Competition since September from 1999 to 2005. In the previous Commission (1995-1999) he was in charge of the Single Market, Financial Services and Tax Policy. From 1989 to 1994 he had served as Rector of Milan's Bocconi University, of which he has been appointed President in 1994. At Bocconi he was professor of Economics and Director of the Institute of Economics. Born in Varese in 1943, he received a degree in economics at Bocconi University and pursued graduate studies at Yale University. He taught at the Universities of Trento and Turin before returning to his alma mater. He has also been a member of the board of directors of several companies. He has been contributing regularly to the Italian newspaper "Corriere della Sera" from 1978 to 1994. A collection of his essays was published under the title "Il governo dell'economia e della moneta. Contributi per un'Italia europea: 1970 - 1992" (Longanesi, 1992). He is the author of many publications, in particular on Monetary and financial economics, Fiscal policy and European integration. His recent publications include "Intervista sull'Italia in Europa" (Laterza, 1998). He served as President of SUERF (Société Universitaire Européenne de Recherches Financières) from 1982 to 1985 and of the Treasury Ministry's Committee on the Italian financial system which indicated the lines for the nation's financial policies for the Eighties. In the late 1980's he was a member of the Industry Ministry's Committee which drafted Italy's first law on Competition.

Rainer Münz is Head of Research at Erste Bank in Vienna and Senior Fellow at the Hamburg Institute of International Economics (HWWI). A teacher by profession, Nicole Notat has played an active role in French and European trade unionism. Nicole Notat founded VIGEO in July 2002, in a pioneer shareholder formula that brings together large European companies, European trade unions, financial operators. In 2005 the President of the French Republic, nominated her to be a member of the High Authority against Discriminations and Equity (HALDE). She was the first woman to lead a large French trade union, the CFDT, where she was Secretary General from 1992 until 2002. She was president of the UNEDIC between 1992 and 1994 and between 1996-1998.

Nicole Notat born the July 26th 1947 with Chatrice in the Marne is the general ex-secretary of the trade union CFDT, and is currently chairman of Vigeo, where it engages for a design of the Sustainable development.

It was the first woman to direct a trade-union confederation to France.

Biography

Nicole Notat is resulting from a family of farmers, it chooses to become teacher for problem child. Teacher in formation with IUFM of Bar-le-Duc, it takes part in it in the movement of May 68.

This figure of the union world adheres to the democratic French Confederation work (CFDT) in 1969. It becomes secretary of the General trade union of State education (Sgen) - CFDT Meuse in 1970, then member of the regional executive commission Sgen Lorraine in 1972. In 1978, it occupies the regional position of secretary general Sgen Lorraine and enters to the council of the Regional union CFDT Lorraine. In 1982, it is member of the confederal Executive commission and national secretary of the sector education then, in 1985, in charge of the sector employment/professional training.

Its progression within CFDT is remarkable, indeed it adheres to SGEN-CFDT in 1969, becomes assistant secretary of CFDT in 1988 then finally general secretary in 1992.

With the Unedic it was president of the council (1992 to 1994), secretary of the board of directors (1994 to 1996) and president of the board of directors (1996 to 1998).

During the Parisian demonstration of the public office on October 17th 1996, it highly is taken with part for its support the previous year for the plan Juppe. She is then shown of treason by demonstrators.

In 2002, it passed the relay of CFDT to Francois Chereque to the congress of Nantes. It then creates Vigeo European company of social and environmental performance evaluation of the companies RSE. As a President de Vigeo, it took again agency ARESE, first social credit rating agency in France.

Biography - Lech Walesa



Lech Walesa was born on September 29, 1943 in Popowo, Poland. After graduating from vocational school, he worked as a car mechanic at a machine center from 1961 to 1965. He served in the army for two years, rose to the rank of corporal, and in 1967 was employed in the Gdansk shipyards as an electrician. In 1969 he married Danuta Golos and they have eight children.

During the clash in December 1970 between the workers and the government, he was one of the leaders of the shipyard workers and was briefly detained. In 1976, however, as a result of his activities as a shop steward, he was fired and had to earn his living by taking temporary jobs.

In 1978 with other activists he began to organise free non-communist trade unions and took part in many actions on the sea coast. He was kept under surveillance by the state security service and frequently detained.

In August 1980 he led the Gdansk shipyard strike which gave rise to a wave of strikes over much of the country with Walesa seen as the leader. The primary demands were for workers' rights. The authorities were forced to capitulate and to negotiate with Walesa the Gdansk Agreement of August 31, 1980, which gave the workers the right to strike and to organise their own independent union.

The Catholic Church supported the movement, and in January 1981 Walesa was cordially received by Pope John Paul II in the Vatican. Walesa himself has always regarded his Catholicism as a source of strength and inspiration. In the years 1980-81 Walesa travelled to Italy, Japan, Sweden, France and Switzerland as guest of the International Labour Organisation. In September 1981 he was elected Solidarity Chairman at the First National Solidarity Congress in Gdansk.

The country's brief enjoyment of relative freedom ended in December 1981, when General Jaruzelski, fearing Soviet armed intervention among other considerations, imposed martial law, "suspended" Solidarity, arrested many of its leaders, and interned Walesa in a country house in a remote spot.

In November 1982 Walesa was released and reinstated at the Gdansk shipyards. Although kept under surveillance, he managed to maintain lively contact with Solidarity leaders in the underground. While martial law was lifted in July 1983, many of the restrictions were continued in civil code. In October 1983 the announcement of Walesa's Nobel prize raised the spirits of the underground movement, but the award was attacked by the government press. The Jaruzelski regime became even more unpopular as economic conditions worsened, and it was finally forced to negotiate with Walesa and his Solidarity colleagues. The result was the holding of parliamentary elections which, although limited, led to the establishment of a non-communist government. Under Mikhail Gorbachev the Soviet Union was no longer prepared to use military force to keep communist parties in satellite states in power.

Walesa, now head of the revived Solidarity labour union, began a series of meetings with world leaders.

In April 1990 at Solidarity's second national congress, Walesa was elected chairman with 77.5% of the votes. In December 1990 in a general ballot he was elected President of the Republic of Poland. He served until defeated in the election of November 1995.

Walesa has been granted many honorary degrees from universities, including Harvard University and the University of Paris. Other honors include the Medal of Freedom (Philadelphia, U.S.A.); the Award of Free World (Norway); and the European Award of Human Rights.
